The Secretariat of the International Atomic Energy Agency (IAEA) presents its compliments to the IAEA's Member States and has the honour to draw their attention to the **Technical Meeting on External Event Hazard and Risk Assessment for Nuclear Installations under the Framework of the External Events Safety Section** to be held at the IAEA's Headquarters in Vienna, Austria, from **28 to 30 June 2017**.

The purpose of the meeting is to provide an update on the projects being conducted under Phase 2 of the Extrabudgetary Programme of the External Events Safety Section (EESS-EBP). This meeting will serve as a forum for communicating the progress made in the planned activities and for discussing the further development of Phase 2 of the EESS-EBP. The information to be presented will assist the institutions and Member States participating in the EESS-EBP in providing their continued support. Member States and institutions that do not currently participate in the EESS-EBP will also benefit from this information and they will be encouraged to become more involved, through the nomination of national contact persons and, if possible, the provision of resources to the programme.

The attached Information Sheet provides further details of the meeting.

The meeting will be held in English.

Member States are invited to designate one or more participants for this meeting. Member States are strongly encouraged to identify suitable women participants.

The IAEA is generally not in a position to bear the travel and other costs of participants in the meeting. The IAEA has, however, limited funds at its disposal to help meet the cost of attendance of certain participants. Such assistance may be offered upon specific request to normally one participant per country provided that, in the IAEA's view, the participant on whose behalf assistance is requested will make an important contribution to the meeting. The application for financial support should be made at the time of designating the participant.

It should be noted that compensation is not payable by the IAEA for any damage to or loss of personal property. The IAEA also does not provide health insurance coverage for participants in meetings, workshops or training courses or for consultants. Arrangements for private insurance coverage on an individual basis should therefore be made. The IAEA will, however, provide insurance coverage for accidents and illnesses that clearly result from any work performed for the IAEA.
